CONDITIONS OF ENTRY:

- The entry must be clean, complete and in safe working condition. Running on trade plates **IS NOT** permitted.  
The vehicle must have a current MOT certificate (unless exempt) and be insured against third party risks for road use. The Society reserves the right to ask for proof of these items. It is expected that the appropriate VED has been paid, if applicable  
The owner(s) must ensure that all drivers are lawfully qualified to handle the class of vehicle exhibited.  
Steam-driven vehicles will be admitted only if the drivers can show proof of boiler insurance and annual inspection of the organisers  
An unattended vehicle must be securely braked and/or chocked, and **NOT** left with the engine running  
The owner(s) of the vehicle may be held responsible for any weight damage caused by negligence whilst taking part in the event.  
A speed limit of 5 mph shall apply to all vehicles—including modern tender vehicles—in all rally areas off the highway. Competitors must pay full regard to marshals' instructions and conduct themselves in a manner that will not inconvenience other road users, or cause annoyance to the persons at any time.  
Late and substitute entries are permitted, but please try to let us know as soon as possible, by ringing the number below.  
**No vehicle will be allowed to leave the arena until the event is over. In signing this sheet you are agreeing to the Terms and Conditions set by HCVS North East**

PLEASE READ, THEN SIGN THE DELARATION

I have read the conditions of entry printed above and agree to be bound by them.
